### **Issues**

1. Beaver Local Schools – Emergency requirements, 4.618 mills generating \$1.2 million, 5 years, renewal
2. Crestview Local Schools – Construction bond of 2.34 mills generating \$5.2M up to 35 years and a permanent improvements levy of 0.5 mil for a continuing period of time, additional.
3. East Palestine Village – Ordinance amending income tax code and a 0.5% income tax levy increase to a permanent rate of 1.5% for police, fire and municipal operations
4. Sandy Creek Joint Fire Dist – Fire levy, 3 mills, additional, generating \$638,397
5. Wayne Township – Road levy, 4 mills, additional, generating \$70,800 annually
6. West Branch – 0.5% income tax for school district purposes

## **Elimination of a Primary Election**

Section 3513.02 of the Revised Code of Ohio provides that a municipal partisan primary election shall not be conducted under certain circumstances. No primary election will be conducted for a particular political party, if in accordance with R.C. 3513.02, the following occurs:

- No valid declaration of candidacy is filed by a candidate of a political party for election to any of the offices to be voted for at the general election in that year,
- or
- If the number of persons filing declaration of candidacy for nominations as candidates of one political party for election to such offices does not exceed, as to any such office, the number of candidates which such political party is entitled to nominate as its candidates for election to such office.

**The filing deadline for Independent Candidates running in the 2019 General Election is May 6, 2019 by 4 PM**
